

# SEASONS OF FAMILY FARM FUN OFFICIAL RULES

**Odds of winning:** Dependent on the number of entries

**Eligibility:** Open to persons age 18 or older on June 13, 2016.

**No purchase necessary.** A purchase will not improve your chances of winning. Void where prohibited. Promotion is subject to all applicable federal, state and local laws.

**HOW TO PARTICIPATE:** Pick up a Seasons of Family Fun Game Card\* and get your first seasonal stamp at Pallman Farms during Strawberry Season. During Apple Picking Season, show your Game Card at Roba Family Orchard for the second stamp. Ready for Halloween festivities, pumpkins galore and the third stamp on your card? Bring your Game Card to Roba Family Farms. Take your Game Card to Pallman Farms at Turkey Time for your fourth seasonal stamp. For a final stop on your Seasons of Family Fun journey, bring your Game Card to either Roba Family Farms or Roba Family Orchard during the Christmas season, receive your final stamp and enter to win by dropping your card into the Seasons of Fun Jar. To be entered into the drawing, Game Cards must contain entrant's name, address and telephone number. Email is optional. By sharing your email address, you'll be among the first to receive future farm updates and special offers from the Pallman and Roba families. Entrants may participate only once. Winners must provide proof of age, name, mailing address, email and telephone number.
